

## July 29th 2019 - Up to 8 weeks on us - Terms and Conditions:

- 1. The offer is available to new customers who open an account between 1<sup>st</sup> July 2019 and 31<sup>st</sup> August 2019.
- 2. The offer is only available on vehicle hire arranged via the customers nominated account manager.
- 3. You are able to take up the Flexible Hire Offer and or the Minimum Term Offer (set out in "a" and "b" below), Subject to the conditions set out below:

## a. Flexible Hire Offer

- i. This offer is available for all stock flexible hire vehicles, subject to stock availability.
- ii. Vehicles must go on hire on or before 31<sup>st</sup> July 2019, and must remain on hire (with no breaks) until 31<sup>st</sup> October 2019.
- iii. For each vehicle hire commencing between 1<sup>st</sup> July 2019 and 14<sup>th</sup> July 2019 inclusive, a credit equivalent to 10 days rental charges will be applied to the reservation.
- iv. For each vehicle hire commencing between 15<sup>th</sup> July 2019 and 31<sup>st</sup> July 2019 inclusive, a credit equivalent to 7 days rental charges will be applied to the reservation.
